**SUB: PERMISSION FOR SHIFTING OF SCHOOL CAMPUS FROM RITNAND BALVED EDUCATION FOUNDATION, SAIL UNIT COMPLEX, JAGDISHPUR TO BANBHARIA, JAGDISHPUR, AMETHI**

Sir/Madam,

This is with reference to school application No.-CA-90025-2324 dt.30/12/2022 on the subject cited above.

In this connection, I am directed to convey approval of the Board for shifting of school campus as per the details mentioned below on the basis of online documents and data uploaded by school.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

Sl. No.	The school is directed to ensure that :
1	The total number of sections of the school shall be restricted to 14. Further increase of sections, it shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye laws and subject to availability of class rooms of greater than 500 sq ft dimension
2	The school has submitted the renewed NOC for the new site and an inter-departmental letter for site shifting in place of permission of site shifting from old campus to new campus (with complete address) issued by state education department. Thus, the school is required to obtain the said certificate and submit in the compliance within 03 months on SARAS Portal.
3	A videography link covering CwSN toilets separately for Boys and girls on each floor is required to be submitted in the compliance within 03 months on SARAS Poratal. The school ensure that the videography should be started from the entrance of the school building covering the school name prominently displayed at the entrance and other facilities as mentioned herein above.
4	The school shall conduct training of its teachers with CoE Prayagraj and submit the compliance within 03 months on SARAS Portal.

The approval of the Board as mentioned above, is subject to the following conditions:-

- The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
- The school shall renew mandatory certificates from time to time.
- The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.

7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
