

SI. No.	The school is directed to ensure that :
1	The total number of sections of Bal Vatika shall be restricted to 03 (one sections each in Bal Vatika I, II & III respectively).). The total number of sections of the school from class I to X shall be restricted to 23. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension. The maximum number of student in a section should not exceed 40.
2	The school is not running bal-vatika presently. Thus, it is required to submit an undertaking that from upcoming session school will run bal-vatika within 03 months in the compliance
3	The school has converted regular cubicles into CWSN toilets which are small and narrow and there is no room for a wheelchair/walker to navigate. Thus the school shall construct separate toilets for CWSN, boys and girls on every floor with proper permanent signage as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS with videography.
4	The boundary wall is seen as less than the prescribed height of 6 ft (ref IC vide- 5.47) The school shall increase the length of the boundary wall to 6 ft within 3months and submit compliance on SARAS with videography.
5	The physics portion is not seen in Composite lab. The Composite lab should have a separate section for Chemistry, Bilogy section with inbuilt utilities and lab standard table for physics portion. Hence, the school is required to upgrade the lab as per SoPs issued by the Board and submit the compliance through videography within 3 months on SARAS portal.
6	The school has multiple floors. Thus, it is directed to not to use the floors beyond third floor for any academic and non-academic activities. Further, the school is also required to submit the copy of undertaking submitting by school in r/o above though email in the compliance on SARAS portal within 03 months.

7 The school shall conduct training of its teachers with CoE Pune within 3 months and submit the compliance

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- 8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
